We appreciate your interest in DJS education positions. Education positions require certification, or eligibility for certification, by the Maryland State Department of Education. While the majority of DJS education positions are full-time, we occasionally employ part-time teachers.

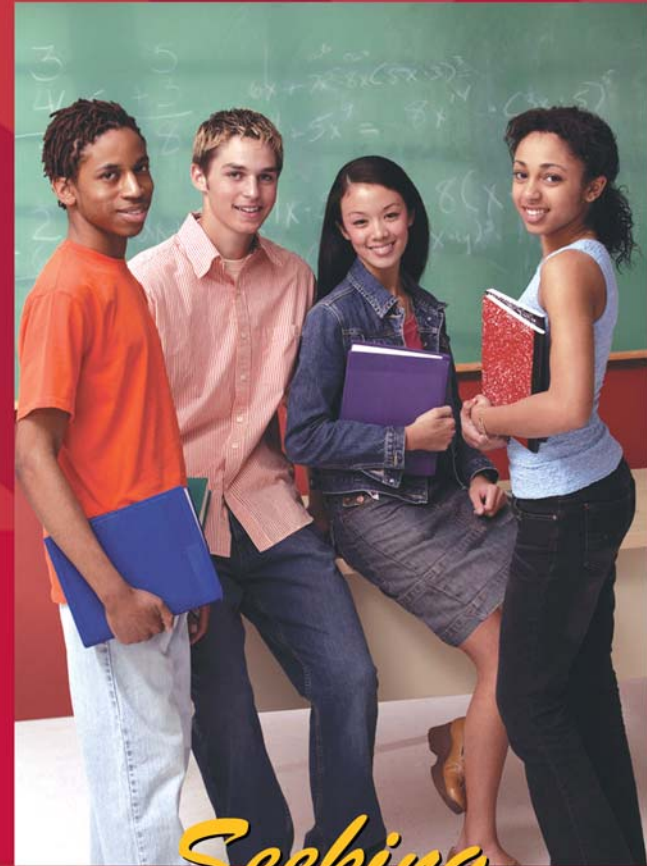
DJS accepts applications on an ongoing basis. The first step is completion of an application for State employment, which is available at [www.djs.state.md.us](http://www.djs.state.md.us) in the Current Job Opportunities section. General and special education teacher applicants should submit the Education Application, EDU-100, which is on the website. Our screening process for education positions includes an interview, reference check, verification of relevant education and experience and criminal background check.

The students in DJS facilities are Maryland's most at-risk, with the greatest need for positive intervention in their lives. Teaching in DJS facilities can be your most rewarding professional career.

Youth in DJS facilities range in age from 12 to 18, and most are age 16 or 17. They have many needs for education, mental health, substance abuse and somatic health services. In addition to educators, professionals in many other disciplines work collaboratively to support youth in DJS facilities.



## DJS Facilities

Students are adjudicated to DJS facilities until their case is decided by the juvenile courts. Students will then either return to the community or be committed to DJS for longer-term treatment.
